## 1. Что нужно сделать в самом начале

### Содержимое упаковки

- TE100-S16D/TE100-S24D
- Руководство по быстрой установке на нескольких языках
- Адаптер источника питания (5V DC, 2A)

Если любой из выше содержание отсутствует, пожалуйста, обратитесь к поставщику.

### Требования к установке

- Компьютер с соответствующим образом установленным сетевым адаптером
- Сетевой кабель категории 5, 5е или 6
- Поверхность под коммутатором должна выдерживать нагрузку минимум в 1,72 кг (3,8 lbs)
- Сетевая розетка должна располагаться в пределах 1,8 м (6 футов) от коммутатора
- Убедитесь в беспрепятственности отвода тепла от коммутатора и адекватности вентиляции его корпуса
- Не устанавливайте на коммутатор тяжелые предметы

## 2. Установка оборудования

1. Подключите адаптер питания к устройству TE100-S16D/TE100-S24D и затем к сетевой розетке.



2. Присоедините сетевой кабель категории 5, 5е или 6 RJ-45 от компьютера к порту Ethernet устройства TE100-S16D/TE100-S24D.



3. Переведите Выключатель в положение «ON» (включено).

- **Зеленый:** Питание включено

- **Зеленый (горит постоянно):** Подключение к порту 100/200 Мбит / с (полудуплексный / дуплексный режим) или 10/20 Мбит / с (полудуплексный / дуплексный режим)
- **Зеленый (мигает):** Данные передачи / приема на 10/20 Мбит / с (полудуплексный / дуплексный режим) или 100/200 (полудуплексный / дуплексный режим)

## Troubleshooting

### **1. After connecting the Switch to a power outlet, the LEDs do not turn on.**

1. Check the connection of the power adapter to the TE100-S16D/TE100-S24D and the power outlet.
2. Check that the power outlet is receiving power.

### **2. After I connect my PCs to the Switch, I am unable to share files.**

1. Check the LEDs on the Switch. Make sure the LINK/ACT LED is on.
2. Check the network cable. The minimum length of the cable is 1.5 m and the maximum length of the cable is 100 m.
3. Disable any software firewall program.
4. Verify that you have file sharing enabled. Please contact your Operating System support for more information.

### **3. After I connect my PCs to the Switch, I can only get onto the Internet from one computer.**

The Switch was not designed to share Internet between multiple computers. You need to get an Internet router such as the TEW-652BRP.

### **4. Where is the uplink port located on the Switch?**

Since all the ports on the Switch are Auto-MDIX, any of the ports can be used as an uplink port.
