# Системные требования

- Компьютер с соответствующим образом установленным сетевым адаптером
- Сетевой кабель категории 5 или 5е
- Сетевая розетка должна располагаться в пределах 1,82 м (6 футов) от коммутатора
- Проверьте надежность подключения адаптера источника питания к гнезду постоянного тока (DC)
- Убедитесь в беспрепятственности отвода тепла от коммутатора и адекватности вентиляции его корпуса
- Не устанавливайте на коммутатор тяжелые предметы

 Подключите адаптер питания к устройству TE100-S5/TE100-S8 и затем к сетевой розетке.

# 1. After connecting the Switch to a power outlet, the LEDs do not turn on.

- 1. Check the connection of the power adapter to the TE100-S5/TE100-S8 and the power outlet.
- 2. Check that the power outlet is receiving power.

### 2. After I connect my computers to the Switch, I am unable to share files.

- 1. Check the LEDs on the Switch. Make sure the Link/ACT LED is on.
- 2. Check the network cable. The minimum length of the cable is 1.5 meters and the maximum length of the cable is 100 meters.
- 3. Disable any software firewall program.
- 4. Verify that you have file sharing enabled. Please contact your Operating System support for more information.

# 3. After I connect my computers to the Switch, I can only get onto the Internet from one computer.

The Switch was not designed to share Internet between multiple computers. You need to get an Internet router such as the TW100-S4W1CA.

#### 4. Where is the uplink port located on the Switch?

Since all the ports on the Switch are Auto-MDIX, any of the ports can be used as an uplink port.
