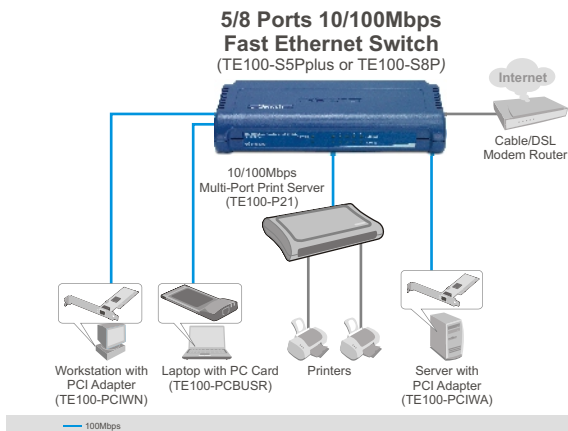
Contenu de l'emballage

- TE100-S5Pplus/TE100-S8P
- Guide d'installation rapide
- Adaptateur secteur

Configuration du système

- Un ordinateur avec un adaptateur réseau correctement installé.
- La surface doit supporter au moins 0,5 kg pour le Switch.
- La prise secteur doit être située à un maximum de 1,82 mètres du Switch.
- Inspectez visuellement la prise d'alimentation et assurez-vous qu'elle est correctement connectée à l'adaptateur secteur.
- Vérifiez la présence d'une source de ventilation adéquate autour du Switch pour une dissipation efficace de la chaleur.
- Ne placez pas d'objets lourds sur le Switch.

2. Installation du matériel

1. Branchez le transformateur AC au TE100-S5Pplus/TE100-S8P ainsi qu'à une prise de courant.



2. Branchez un câble réseau CAT-5 RJ-45 de l'ordinateur vers un port Ethernet disponible du TE100-S5Pplus/TE100-S8P.

Q1: After connecting the Switch to a power outlet, the LEDs do not turn on.

A1: Check the connection of the external power adapter to the TE100-S5Pplus/TE100-S8P and the power outlet. Also check that the power outlet is receiving power.

Q2: When I connect a computer to the Switch's port, the LINK/ACT LED turns on, but the 100Mbps LED remains off.

A2: When the 100Mbps LED remains off, the computer's connection speed is 10Mbps.

Q3: After I connect my PCs to the Switch, I am unable to share files.

A3: First, check the LEDs on the Switch. Make sure the LINK/ACT LED is on. Second, check the network cable. The minimum length of the cable is 1.5 meters and the maximum length of the cable is 100 meters. Third, disable any software firewall program. Fourth, verify that you have file and printer sharing enabled. Please contact Microsoft support for more information.

Q4: After I connect my PCs to the Switch, I can only get onto the Internet from one computer.

A4: The Switch was not designed to share Internet between multiple computers. You need to get an Internet router.
