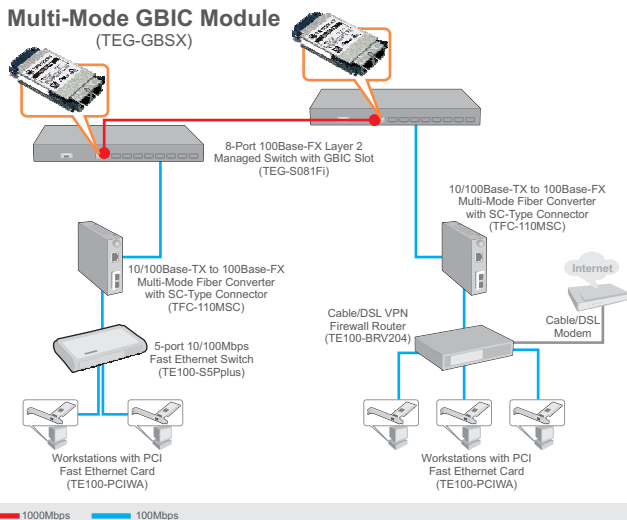

2. Installation du matériel

1. Insérez le module dans un logement libre d'un Switch muni d'un logement GBIC (p. ex. le TEG-S081Fi)

2. Branchez un câble multi-mode de type SC entre le module et un Switch fibre Gigabit à l'aide d'une prise de type SC.



Remarque: Les câbles TX et RX doivent être inversés par rapport à la connexion fibre opposée.

L'installation est maintenant complète.

Q1: Is the Fiber Module hot pluggable?

A1: Yes, it is hot pluggable.

Q2: I can't make a connection. What should I do?

A2: First, verify that you are using the proper fiber cable (e.g. SC-type multi-mode fiber cable). Second, verify that the TX and RX cables have been reversed on the opposing Fiber connection.

Q3: What is the maximum distance that is supported by the Module?

A3: 550 meters.
