



Troubleshooting

Após conectar o TPA-311 a uma tomada de energia a luz PWR não acende.

- 1. Verifique a conexão do adaptador de tensão externo ao TPA-311 e à tomada.
- 2. Verifique que a tomada de energia está recebendo eletricidade.

A luz PWR está acesa, mas a luz LAN não acende. O que devo fazer?

- 1. Verifique que o cabo Ethernet está conectado firmemente no TPA-311 e na conexão posta.
- 2. Tente usar outro cabo Ethernet.
- Terceiro, a distância máxima para Ethernet é 100 metros. Não use um cabo de ethernet maior que 100 metros.

A luz PWR está acesa, mas a luz HPNA não liga. O que devo fazer?

- 1. Verifique que o cabo coaxial esta firmemente conectado ao TPA-311 e ao conector F.
- 2. A máxima distancia é de 1600 metros. Não use um cabo coaxial superior a 1600 metros.
