

- Computer with an available USB 2.0 or 1.1 Type A Port
- SATA I/II, IDE Internal Hard Drive
- CD-ROM Drive
- CPU: 300 MHz or above
- Memory: 256MB or above
- Windows XP, 2000, ME, 98SE

Note: Hard Drive is NOT included.

## 2. Hardware Installation


Note: It is recommended that you format a brand new hard drive first. Please refer to question 2 in the troubleshooting section for more information.

Note: Please refer to the troubleshooting section for instructions on installing the TSE-IS401 on Windows 98SE.

1. Remove the 4 screws from the bottom to detach the cover.



2. Remove the 4 screws to remove the metal hard drive cover.



3. Make sure the jumper settings on the hard drive is set to Master.

4. Connect the IDE data cable and power connector into the IDE hard drive

**5.** Put the metal hard drive cover on top of the hard drive and secure it with the 4 screws.



**6.** Slide the cover back on and secure it with the 4 screws.



**7.** Insert the power cord into the AC Power Adapter.

**8.** Connect the External Power Adapter to the Storage Enclosure and then to a power outlet.

**9.** Connect the provided USB cable into your computer and the TSE-IS401.

**10.** Switch the Power On.


**11.** Drivers will install automatically.

## 3. Accessing Storage Devices on TSE-IS401

1. Double-click on **My Computer**.  
Then double-click on any mounted hard drive under **Network Drives**.

## Q1: My computer does not recognize the TSE-IS401. What should I do?

**A1:** First, verify that the computer meets the minimum requirements as listed in section 1. Second, make sure that you have plugged in the power into the unit and the power cord into an outlet. Third, try plugging the device into a different USB port on your computer.

## Q2: How do I format my brand new hard drive?

**A2:** For Windows 2000/XP, go to **Start -> Settings -> Control Panel -> Administrative Tools -> Computer Management -> Disk Management**. If the **Initialize and Convert Disk Wizard** appears, click **Cancel**. Right click the **Unknown** drive, click **Initialize** and then click **OK**. Right click on the unallocated region of the hard drive and select **New Partition**. Follow the **New Partition Wizard** instructions then click **Finish**. The hard drive will automatically start the formatting process.

For Windows 98SE/ME, right click on **My Computer**, and then click **Device Manager**. Double-click on **Disk drives**, and then double-click on your hard drive. When the hard drive properties window appears, click on the **Settings** Tab. Check **Removable** in the **options** section, select an available drive letter for **Start drive letter** and then click **OK**. Click **Close**. Click **Yes** to restart the computer. Double click on **My Computer**, double-click on the hard drive and click **Yes** to format it.

## Q3: How do I install the TSE-IS401 on Windows 98SE?

- A3:**
- 1) Insert the Driver CD-ROM into the CD-ROM drive
  - 2) Go to start -> run -> type in **D:\Driver\Win98\Setup.exe** and click **OK**. D represents the drive letter of your CD-ROM drive.
  - 3) Setup successful will appear. Click **OK**.
  - 4) Follows steps 1-10 in Section 2 to complete the installation.

## Q4: My computer does not recognize my hard drive(s)? What should I do?

**A4:** First, verify that the device is installed properly. Right click on My Computer Properties. Click on **Hardware** and then **Device Manager**. Double click on **Disk Drives**. Make sure that your hard drive is listed and there is no yellow question mark or exclamation point. Second, if you are attaching a brand new hard drive, format the drive. Please refer to question 2 for more information. Third, the hard drive that is connected to the TSE-IS401 must be formatted in FAT-16 or FAT-32 in order for Windows 98SE or ME to recognize it

## Limited Warranty
