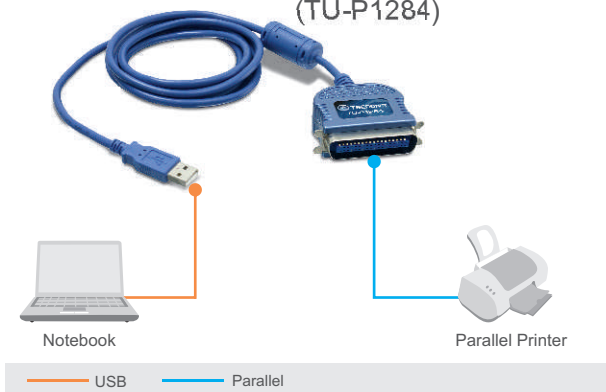

2. Installation du matériel

Remarque : Si vous installez une nouvelle imprimante, il se peut que vous deviez installer le pilote de celle-ci. Consultez le mode d'emploi de votre imprimante concernant l'installation du pilote.

1. Allumez votre ordinateur et attendez que le bureau Windows apparaisse.



2. Branchez la prise parallèle au port parallèle de l'imprimante et allumez l'imprimante.



3. Branchez l'adaptateur à un port USB disponible de votre ordinateur.

3. Installation du pilote

Remarque : Après avoir connecté le TU-P1284 à une prise USB, Windows (XP/2000/ME/98SE) détectera automatiquement le périphérique. Suivez les instructions fournies dans la partie adéquate ci-dessous pour installer le pilote.

Windows 2000/XP

1. Après le redémarrage de votre PC, Windows installera automatiquement votre nouveau matériel.



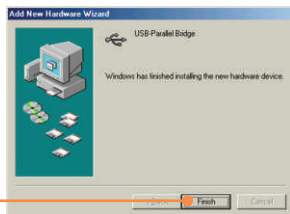

3. Cliquez sur **Finish (Terminer)**.

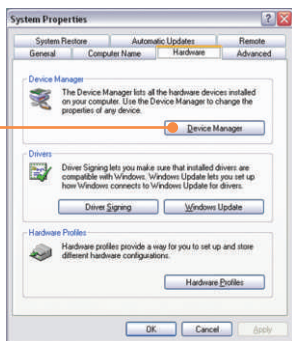

4. Vérification de l'installation

Windows 2000/XP

1. Faites un clic droit sur **Poste de travail** et cliquez sur **Propriétés**. Sous l'onglet **Matériel**, cliquez sur **Gestionnaire de périphériques**.



2. Vérifiez que le **Support d'impression USB** est installé et qu'aucun point d'exclamation n'apparaît.

Q1: How can I uninstall the USB to Parallel Converter Driver?

A1: For operating systems that require a driver, unplug the USB to Parallel Converter from your computer and run the UNINST.EXE program located on the included Driver CD-Rom.

Q2: Can I connect or disconnect the USB cables while the computer is on?

A2: Yes, you can connect or disconnect the USB cable while the computer is on, because the USB interface is Plug-and-Play and hot-pluggable.

Q3: My computer has a USB interface but the USB port doesn't seem to work. What should I do?

A3: Check that your computer's BIOS has its USB option enabled. Also follow the steps in Section 4: Verify Installation and make sure that there are no exclamation points. For more information regarding BIOS settings, please refer to your computer's User Manual.
