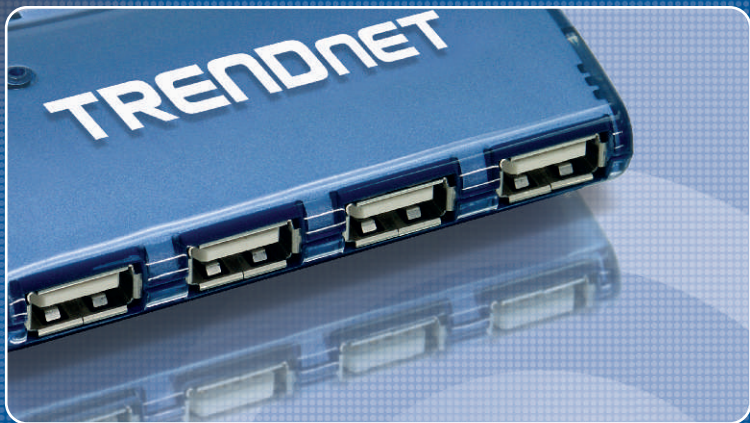

1. Before You Start



Package Content

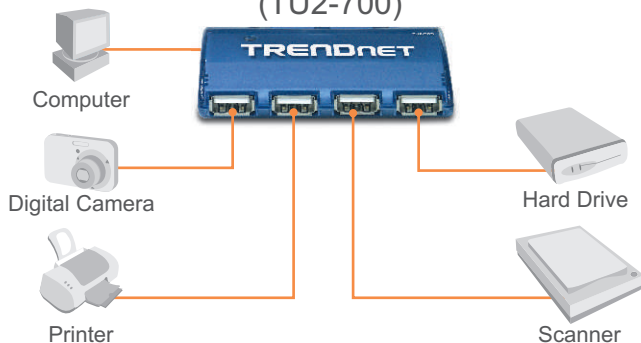
- TU2-700
- USB Cable (Type-A to Mini-B, Male)
- AC Power adapter
- Quick Installation Guide

System Requirements

- Pentium 300Mhz or faster with at least 64MB RAM
- Computer with an available USB port
- Windows XP, 2000, ME, or Mac OS X or later

Application

7-Port High-Speed USB 2.0 Hub (TU2-700)



480Mbps USB 2.0
12Mbps USB 1.1 *

* Backwards compatible with USB 1.1 at 12Mbps

2. Install Hardware

Note: To take advantage of USB High Speed, all your USB devices must be USB 2.0 High Speed.

1. Turn on your computer and wait until startup completes.

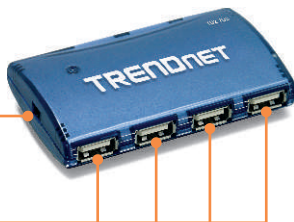


2. Connect the included USB cable to the USB Hub, and then to your computer's USB port.



3. Connect the AC Power Adapter to the USB Hub.

4. Connect USB device to an available USB port.



Your installation is now complete.

Q1: Can I connect or disconnect the USB cable while the computer is on?

A1: Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on because the USB interface is Plug-and-Play and hot-pluggable.

Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?

A2: Yes, it works but it may cause problems when connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

Q3: After successfully installing the TU2-700 USB 2.0 Hub, I connected my external USB device to the USB port, but it doesn't seem to work. What should I do?

A3: If you have an external AC power adapter that came with the external USB device, connect the AC power adapter to the device and power on the device. Also make sure that you have installed the correct driver for your external USB device.
