

## 2. Installation du matériel

1. Allumez votre ordinateur et attendez que le bureau Windows apparaisse.



2. Branchez le lecteur de carte à un port USB de votre ordinateur.



### 3. Installation du pilote

Remarque : Après avoir connecté le TMR-61U2 à une prise USB, Windows (XP/2000) détectera automatiquement le périphérique. Suivez les instructions fournies dans la partie adéquate ci-dessous pour installer le pilote.

#### Windows 2000/XP

1. Après le redémarrage de votre PC, Windows installera automatiquement votre nouveau matériel.




# 4. Vérification de l'installation

## Windows 2000/XP

1. Faites un clic droit sur **My Computer** (Poste de travail) et cliquez sur **Property** (Propriétés). Sous l'onglet **Matériel**, cliquez sur **Device Manager** (Gestionnaire de périphériques).



2. Vérifiez que le **Volume** générique et le **périphérique de stockage de masse USB** sont installés et qu'aucun point d'exclamation n'apparaît.



3. Ouvrez le **Poste de travail** et vérifiez que les quatre disques amovibles apparaissent.

**Q1: Can I connect or disconnect the USB cables while the computer is on?**

**A1:** Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on, because the USB interfaces are Plug-and-Play and hot-pluggable.

**Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?**

**A2:** Yes, it works but it may cause problems for connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

**Q3: After successful installation of the TMR-61U2 USB 2.0 6-in-1 Memory Card Reader/Writer, I inserted my memory card into the slot and it is not working? What should I do?**

**A3:** Make sure the memory card is properly inserted in the right slot and make sure the light comes on.
