

Применение

Workstation with USB 2.0 All-in-1 Memory Card Reader/Writer (TMR-61U2)



2. Установка оборудования

1. Включите компьютер и дождитесь загрузки рабочего стола Windows.



2. Присоедините устройство считывания карт к имеющемуся порту USB компьютера.



3. Установка драйверов

Примечание: после установки платы TMR-61U2 в гнездо USB система Windows (XP/2000) автоматически распознает новое оборудование. Перейдите к соответствующему разделу ниже для установки драйвера.

Windows 2000/XP

1. После перезагрузки Windows автоматически выполнит установку нового оборудования.




4. Проверка результатов установки

Windows 2000/XP

1. Правой кнопкой мыши выберите **Мой компьютер** и далее **Свойства**. Выбрав закладку **Оборудование**, щелкните по кнопке **Диспетчер устройств**.



2. Убедитесь в том, что установлены следующие устройства: **Generic volume** и **USB Mass Storage Device**. и возле них нет восклицательных знаков.



3. Выберите **Мой компьютер** и убедитесь в появлении четырех «съемных дисков».

Q1: Can I connect or disconnect the USB cables while the computer is on?

A1: Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on, because the USB interfaces are Plug-and-Play and hot-pluggable.

Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?

A2: Yes, it works but it may cause problems for connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

Q3: After successful installation of the TMR-61U2 USB 2.0 6-in-1 Memory Card Reader/Writer, I inserted my memory card into the slot and it is not working? What should I do?

A3: Make sure the memory card is properly inserted in the right slot and make sure the light comes on.
